



**St. Teresa of Avila Catholic School
Contract for Payment of Tuition
2010-2011**

This contract will be effective the date signed and is for the full tuition amount as shown below, as applicable to your family.

Category A:

St. Teresa of Avila Parish Rate

First Child	\$3,375.00
Second Child	\$1,950.00
Third and each additional child	\$1,575.00

Category B:

Non-Parishioner Rate

First Child	\$4,900.00
Second Child	\$2,750.00
Third and each additional child	\$2,200.00

In order to meet the qualifications of Category A, families must attend mass at St. Teresa of Avila weekly, be registered in the parish and share your time, talent and treasure. Families must have a previous 12 month (May 1 – April 30) history of contributions of at least \$500.00 to St. Teresa of Avila Parish and an annual gift of \$50.00 or more to CSA. Please use your church envelopes each week for your contributions. No “one time” or “once a year” monies will be accepted in order to qualify for Category A.

The following payment plans are available to all. **Please circle your choice A, B or C below.**

- A. Full tuition payment due on/before August 10, 2010.
- B. One-half due on/before August 10, 2010 and the balance due on/before January 10, 2011
- C. Ten monthly payments due on/before the 10th of each month – Beginning August 10, 2010 and ending May 10, 2011.

If choosing option 2 or 3 enrollment is required in the SMART Tuition Collection program for an annual fee of \$43.00 per family which is added to your first tuition payment.

All tuition payments are due and payable on/or before the 10th of the month according to the specific payment plan, and will become delinquent after the 20th of the month. A school imposed **late fee of \$25.00** will be applied to each late payment. In addition, a **late fee of \$20.00** is imposed by SMART Tuition Collection for each late payment. A charge of **\$25.00** will be assessed for any check received at the school that is returned by the bank due to insufficient funds or closure of a bank account. After two (2) insufficient funds checks, checks will no longer be accepted for payment of any kind in the school.

Registration and school fees are not refundable and will not be applied to other expenses. Tuition will not be prorated or refunded, except for circumstances outside the control of the family (i.e., a job transfer to another city), and authorization from the Finance Committee.

If tuition and/or other fees have not been paid by the end of each semester without making previous arrangements with the administration, a student’s placement will not be held for the next semester. All payments, fees, etc. must be completely current before you may register for the following school year. All payments, fees, etc. must be completely current by June 1st to allow your child(ren) to return the following year.

The school will withhold report cards and transcripts to other schools if payments are not current by the appropriate dates. Continual refusal to pay outstanding tuition or fees will be referred to a legal or collection agency.

The document entitled, “St. Teresa of Avila Catholic School Additional Parental & Financial Requirements” is hereby incorporated by reference and made a part of this contract.

The undersigned has enrolled their child(ren) at St. Teresa of Avila Catholic School for the 2010-2011 school year and has read this contract and agree to all the terms and conditions including the prompt payment of tuition. I/We understand this is a legally binding contract and that failure to comply with any of the above will be sufficient cause for dismissal of our child(ren) from St. Teresa of Avila Catholic School. This contract constitutes the entire agreement for payment of tuition and cannot be modified except by written agreement by all parties.
